

In the name of God, the most Gracious, the most Merciful

Based on the agreements = concluded among the Palestinian factions to bring an end to division, it was agreed upon the following implementation mechanisms:

1. A national unity government, whose civil and security responsibilities are to be separated, shall be formed to wield full competences across the Palestinian Authority-run areas, based on a Palestinian political system and pursuant to applicable laws. The government shall abide by the items of the National Reconciliation Document of 4/5/2011 aimed to end all forms of division and restore unity among institutions in the West Bank and the Gaza Strip. The government shall also bear the responsibility of maintaining favorable atmosphere for the holding of comprehensive general elections, reconstruction, lift of siege, addressing the effects of siege in any number of forms, settling the issue of passages, restructuring security apparatuses pursuant to the Cairo Agreement, and tackling the issue of employees in accordance with the mechanism stipulated in the Cairo Agreement of 2011 and Cairo agreements of 25/9/2014. The national unity government shall form a legal and administrative committee based on discussions with Fatah and Hamas movements, in such a way that integrates all employees into the employment hierarchy of the PA, provided that a part of their salaries is reimbursed during the work of the committee. (The final agreement on the issue of employees shall be concluded upon meeting brethren Abu Mazen and Abu al-Walid.)
2. A national unity government shall be formed upon discussions and agreement between the President and the Palestinian powers, factions, and prominent figures. The government shall take oath before the President following the issuance of a decree to form it, pursuant to applicable laws and rules.
3. Presidential, parliamentary, and National Council elections shall be held. The President sets the elections date after discussions with all national powers and prominent figures, provided that elections are to be held 6 months following the national unity government formation, while implementing all the requirements and preps for the general elections and settling the related unsolved issues, such as the passing of related regulations and laws.
4. The implementation of the agreement to activate the legislative council to duly fulfill its tasks shall be reiterated. The President shall issue a special decree, calling on the legislative council to hold its regular meeting 6 weeks following the formation of the national unity government. Parliamentary blocs and lists prepare for the meeting in the run-up period leading to the meeting.
5. The meeting of the Activation and Development Committee shall be held within a maximum period of 5 weeks as of the date of the formation of the national unity government, for it to fulfill its tasks stipulated in the Cairo Agreement of 2011. The continuity of its meetings shall be affirmed for it to fulfill the assigned tasks.
6. As soon as it is formed, the national unity government shall wield competences and responsibilities, dealing with the effects of division, including societal reconciliation, public liberties, and cooperation with the Public Liberties Committee and Societal Reconciliation Committees and their related sub-committees in this regard to fulfill its tasks according to the Reconciliation Agreement of 4/5/2011.
 - The basis of discussions herein mentioned shall be the agreement and consensus by and between Fatah and Hamas movements.
